


UGC No. F.29-1/2005(JCRC) dated 3rd August, 2010 (JCRC Report on Restructuring/Rationalization of certain cadres/posts)

- 1) The report represented sanctioned strength of 09 for the post of Head Clerk (pay scale 5500-9000) and existing person in the post have been shown as 08; whereas as per the Pay roll and Office Records of Gujarat Vidyapith, the actual person in position were 12 (twelve) in the pay scale of 5500-9000.
- 2) As per JCRC report the foll. sanctioned strength OS (02-existing 01), Accountant (01), Head Clerk (09-existing 08) and Cashier (01) i.e. total 11 (existing) have been rationalized as Assistant (11) in the pay scale of 5000-8000.
- 3) As there were 02 post of OS (in diff pay scale than Head Clerk), the roster has been prepared separately for OS and not considered in post of Head Clerk.
- 4) As Cashier and Accountant are isolated posts (in pay scale of 4000-6000) the reservation roster is not required, they are not considered in the post of Head Clerks.

* These six (06) incumbents were in the pay scale of Rs. 5500-9000 (pre-revised Rs. 1640-2900) as Head Clerks and were considered as Office Superintendent equivalent in the pay scale of Rs. 6500-10,500 (pre-revised Rs. 2000-3500), w.e.f. 01-04-1995 (exception - Shri Kantilal N. 
